Stonegate Mortgage Corp., 9190 Priority Way West Drive, suite 300, Indianapolis (www.stonegatemt.com), originates, acquires, sells, finances and services residential mortgage loans in the U.S. The firm had its initial public offering on Oct. 10, 2013. For the first quarter ending March 31, the company reported a net loss of \$7.9 million, or 31 cents per diluted share, on revenue of \$38.3 million. That compares with a net income of \$9.7 million, or 86 cents per diluted share, on revenue of \$38.9 million a year earlier. The company's shares trade on the New York Stock Exchange under the ticker symbol SGM. Information for Proxy Corner was taken from Yahoo!
