In the first quarter of 2016, the company lost \$4.0 million, or 7 cents per share, on revenue of \$83.9 million. In the same period a year earlier, the company earned \$4.4 million, or 7 cents per share, on revenue of \$83.5 million. Angie's List's shares trade on the Nasdaq under the ticker symbol ANGI.
