Kimball Electronics Inc., 1205 Kimball Blvd., Jasper, manufactures electronics for customers in automotive, medical, industrial and other fields. In the fiscal year that ended June 30, 2017, Kimball Electronics earned \$34.2 million, or \$1.24 per share, on sales of \$930.9 million. A year earlier, the company earned \$22.3 million, or 77 cents per share, on sales of \$842.1 million. Kimball Electronics shares trade on NASDAQ under the ticker KE.
